Applications for the 2024-25 academic year are accepted from January – May 15, 2024.

Funds are awarded in two rounds: round one deadline is March 15, 2024 round two deadline is May 15, 2024

Families apply through FACTS Grant & Aid Assessment at *online.factsmgt.com/aid.* Application must be done online.

Diocesan Employee Tuition Assistance Program

The David & Linda Kaltenbach Family Fund is a tuition assistance opportunity for fulltime Catholic school employees of the Catholic Diocese of Cleveland whose children are K-12 students. This scholarship is available only to parents employed by the school; parish and general Diocesan employees are not eligible.

• Award amounts are based upon the number of applications received.

Special Scholarships Through Diocese

<u>M. Thomas Moore Elementary Scholarship – DEADLINE March 1, 2024</u>

Awards 4 scholarships of \$500 each academic year to elementary students in the Diocese of Cleveland.

<u>Bishop's Scholarship for Excellence – DEADLINE March 1, 2024</u>

Awards 20 scholarships of \$1,200 each academic year to elementary students in the Diocese of Cleveland.

Requires an essay by the student (this year on a corporal and spiritual work of mercy)



Emergency Diocesan Financial Aid

AVAILABLE NOVEMBER 1 - MAY 1 EACH SCHOOL YEAR

Emergency Tuition Assistance Grants are available to families with children in elementary and/or high schools in the Diocese of Cleveland, who are experiencing a major family crisis and cannot meet their tuition obligation.

The school should discuss options available to the family at the local level first. This may include a payment plan and/or local financial assistance.

If all of these options have been exhausted, the school can request an application for the family.



Angel Scholarships



- The amount of the gift can be used by the donor as a TAX CREDIT for taxes owed to the State of Ohio.
- Last date to get a tax credit for 2023 State of Ohio taxes is April 15, 2024.

T.Payer owes \$1000 in taxes to the State of Ohio	\$1,000

• Funds donated to Angel Scholarships are placed in a pool of funds to be distributed by the school

Angel Scholarships

Designated vs. Undesignated Funds

Recipients:

- State Law Requires that Low Income be Prioritized (< 300% of the federal poverty level): "there must also be a remaining parent commitment owed for a tuition balance to be eligible for an Angel Scholarship"
- * "Other considerations could be applied to these funds such as siblings in Catholic schools, unusual family circumstances, tuition history, etc."
- "Will Angel Scholarships be awarded to applicants that are not low income? All K-12 students that attend a school in the Diocese of Cleveland and apply are eligible to receive an Angel Scholarship.
 While applicants that are under 300% of the poverty threshold will be prioritized, applicants that are over this threshold are also eligible for an Angel Scholarship, based on availability of funds."

ASSOCIATION OF OHIO COMMODORES SCHOLARSHIP GUIDELINES & APPLICATION 2024-2025 Academic Year

Applications must be emailed/postmarked by May 15, 2024

The Association of Ohio Commodores Scholarship Fund provides support for educational scholarships to students who are accepted into and attend primary and secondary schools in Ohio.

Eligibility Criteria: All Scholarship awards must be used for tuition and related expenses at the recipient's educational institution. Scholarships will be awarded from the Fund to students meeting the following criteria:

- 1. Must be accepted into and attend primary and secondary schools in Ohio; and
- 2. Priority will be given to low-income primary and secondary school students.

 Both the Church and School receive funds for grants and scholarships from donors and other third parties

Must be used in accord with donor intent

- Time for submission varies and some require decisions based on information already submitted
- Additional Information will be provided through the Wednesday folder or, if other criteria are met, via adjustment of tuition in FACTS.



#WeGiveCatholic Matches

- # School has been participating in #WeGiveCatholic; the funds for the 2022 and 2023 programs were designated for STREAM funding
- # By setting a strategy, schools are able to receive matching grants that then must be used for tuition assistance





Endowment Scholarships

- > The Endowment holds about 20 separate scholarships
- Some have specific criteria (e.g., member of a military service or civilian officer such as police/fire/paramedics; specific attributes of the student)
- Some require nominations; some do not
- Some are based on financial need or consider it as one of the criteria; others do not
- Some scholarship funds provide multiple awards in a single year
- > Generally awarded twice a year: at the Catholic Schools Mass and at the end of the school year

Deadlines: May 10, 2024 for End of Year Scholarships (applied the following school year)



Parish Scholarships

- Parishes, including St. John Vianney, may award scholarships
- Some have specific scholarships at the parish

 (e.g., the Holy Name Scholarship at St. Justin
 Martyr) and general scholarships (all have criteria)
- St. John Vianney Parish Scholarship (vs. specific scholarship) requires an application.
- DEADLINE September 15, 2024 for SJV Parish Scholarship for the 2024-2025 School Year

Jon Peterson Scholarships

- The Jon Peterson Special Needs (JPSN) Scholarship Program provides scholarships to students who are eligible to attend kindergarten through 12th grade and have an Individualized Education Program (IEP) from their district.
- The amount of each scholarship is based on the primary condition identified on the student's Evaluation Team Report (ETR).
- Students must be enrolled in the scholarship program for the entire program year to receive the full scholarship amount.

Checklist for Scholarship & Financial Aid Applications





Potential Factors in Awarding of Scholarships

- Service to Country/Community (e.g., military, police, fire)
- Family health issues (parent or child) especially significant chronic issues (e.g., Parkinson's, cancer) or immediately acute issues (e.g., heart attack)
- Death of parent; death of person paying tuition
- Single family household
- Grandparents/Third parties living in home and supported by family
- IEP student

• Number of children in family

- Multiple children in Catholic School; multiple children about to enter Catholic School
- Catholic high school student(s) and, to some extent Catholic college
- Leadership of school program as a volunteer (may not be considered since volunteer activities are not considered for some scholarships)
- Event that results in a lowering of income (e.g., divorce, loss of job)



Payment of Tuition in FACTS

- Tuition in FACTS will not be adjusted until the Ohio Department of Education advises All Saints that the scholarship has been awarded and a signed acceptance form has been returned to the school.
- Every school year requires a scholarship award notice from the State. A School cannot adjust FACTS based on previous school year award amount.
- First payment for 2024-2025 school year is due in August 2024. Parents can choose the 5th or the 20th of a month for payment.
- When selecting payment plan option, consider when you will be completing the new or renewal EdChoice scholarship application from the State of Ohio. As always, the earlier the better!
- After returning the acceptance form to the school, it will be between 5 and 10 business days for FACTS to be adjusted.
